### NOTIFICATION

The 7th September, 2016

**S.R.O. No.401/2016**— Whereas, the draft of certain rules further to amend the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, was published, as required by Section 392 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950) in the Extraordinary issue No. 1004, dated the 2nd June, 2016 of the *Odisha Gazette* under the notification of the Government of Odisha in the Housing & Urban Development Department No. 13269-HUD-13-LEGIS-67-POLICY-15-41/2015/HUD., dated the 2nd June, 2016 bearing **S.R.O. No. 193/2016**, inviting the objections and suggestions from all the persons likely to be affected thereby within a period of thirty days from the date of publication of the said notification in the *Odisha Gazette*;

And, whereas, no objection or suggestion has been received in respect of the said draft within the stipulated period;

Now, therefore, in exercise the powers conferred by Section 387 of the said Act, the State Government do hereby make the following rules further to amend the Odisha Municipal (Delimitation of Wards, Reservation of Seats and conduct of Election) Rules, 1994, namely:—

1. (1) These rules may be called the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Amendment Rules, 2016.

(2) They shall come into force on the date of their publication in the *Odisha Gazette*.

2. In the Odisha Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 (hereinafter referred to as the said rules) in rule 2-A; —

(a) in sub-rule (5), for the words and numericals "final notification in Form- XXII" the words and numericals "provisional notification in Form-XXII" shall be substituted ; and

(b) after sub-rule(5), the following sub-rules shall be inserted, namely :—

"(6) Any person aggrieved by the orders passed by the District Magistrate under sub-rule (4) and upon publication of provisional notification in Form XXII may file an appeal before the State Government under the second proviso to sub-section (3) of Section 12 within fifteen days from the date of publication of the notification in Form XXII, which shall be disposed of by the Appellate Authority within the period of thirty days from the date of its filing and if no appeal is filed before the State Government, after expiry of the stipulated period the State Government shall intimate to the District Magistrate concerned accordingly.

(7) The District Magistrate, after making such alterations as per the order of the Appellate Authority, if any, as may be necessary, shall publish in the notice board(s) of his office and office of the concerned Municipality, the final notification in Form-XXII-A showing the division of area of the Municipality into wards and reservation of seats therein as required under sub-section(3) of Section 12 and shall forward forthwith a copy of such notification to the Election Commission, to the Government and to the concerned Municipality."

3. In the said rules, for Forms-"XXI" and "XXII", the following Forms shall be substituted, namely:—
