## DELEGATION ORDER

Sub: Delegation of powers to Er. Debasundar Mohapatra, City Engineer, BMC under Section 30 of OMC Act 2003 in relation to public works carried out by BMC.

1. Whereas, Er. Debasundar Mohapatra, City Engineer is being appointed by Government of Odisha as per the post mentioned in Schedule-A under Rule-17 of the Odisha Municipal Corporation Rules, 2004.
2. Whereas, Section 126 defines powers of City Engineer and other officers of Corporation.
3. Now, therefore, I, Prem Chandra Chaudhary, IAS, Commissioner, Bhubaneswar Municipal Corporation in exercise of the powers conferred on me under Section 30 of Odisha Municipal Corporation Act, 2003, Notification SRO No 211/2017 dtd 10.5.2017 and Notification No 12761/HUD dtd. 22.5.2018 do hereby delegate the power to Er. Debasundar Mohapatra, City Engineer who shall accord Administrative approval for all the works within ward budget and as schedule "A". He shall also function as Sanctioning Authority for all developmental works within Rs.10 Lakhs (Rupees Ten Lakhs) only.
4. This Order will come into force with immediate effect and will remain valid until further orders.
