## DELEGATION ORDER

Sub.:- Delegation of powers to Er. Sri Arun Kumar Nayak, City Engineer, BMC under section 30 of OMC Act 2003 in relation to public works carried out by Bhubaneswar Municipal Corporation, Bhubaneswar.

1. Whereas Er. Sri Arun Kumar Nayak, City Engineer is being appointed by Government of Odisha as per the post mentioned in Scheduled-A under Rule-17 of the Odisha Municipal Corporation Rules, 2004.
2. Whereas, U/s-126 defines powers of City Engineer and other officers of Corporation.
3. Now, therefore, I, Sri Sanjay Kumar Singh, IAS, Commissioner, Bhubaneswar Municipal Corporation in exercise of the powers conferred on me under Section 30 of Odisha Municipal Corporation Act, 2003 and read with general provisions regarding contracts under section 282 of Odisha Municipal Corporation Act-2003 and Notification No. 12761/HUD dated 22.05.2018 do hereby delegate the power to Er. Sri Arun Kumar Nayak, City Engineer who shall accord Administrative approval, in file, for all the works within approved ward budget and shall accord administrative approval upto Rs 50 Lakhs, in file where specific project has been duly approved in budget. He shall also be delegated under Rule-30 of Odisha Municipal Corporation Rule-2004 read with Notification SRO No. 211/217 dated 10.05.2017 with the power to sanction up to Rs 10 lakhs (Rupees Ten Lakhs only) against the duly approved project in case all the procedures has been duly followed.
4. He is also delegated powers conferred on me under Section- 277 read with Notification No. 12767/HUD dated 22.05.2018 to sanction the expenditure involved in a contracts to be made where sanction has been made by the appropriate authority related projects of ward budget or any other budget duly approved by the appropriate authority.
5. This order will come into force with immediate effect and will remain valid until further orders.
