ORDER

Sub.: Delegation of powers to Er. Prasanta Kumar Mishra, EE, Div. No. II, BMC under Section 121 of OMC Act, 2003 in relation to Public Works except Engineering & Sanitation Cell carried out by Bhubaneswar Municipal Corporation, Bhubaneswar.

1. Whereas, Executive Engineers are being appointed by Government of Odisha as posts mentioned in Schedule-A under Rule-17 of Odisha Municipal Corporation Rule, 2004.
2. Whereas, under section-126 defines powers of City engineer and other Officers of Corporation.
3. Now, therefore, I, Sri Vijay Amruta Kulange, IAS, Commissioner, Bhubaneswar Municipal Corporation in exercise of the powers conferred on me under Section-30 of Odisha Municipal Corporation Act, 2003 & Govt. in H & UD Department notification No. SRO 211/2017 dated 10.05.2017, do here by delegates with the power to Er. Prasanta Kumar Mishra, EE, Div. No. II, BMC for sanction up Rs. 25 lakhs (Ruprees twenty five lakhs) only against the duty approved project in case all the procedures has been duly followed.
4. He is also delegated power conferred on me under Section-277 read with notification no. 14072/HUD dated 11.08.2021 to sanction the expenditure involved in a contracts to be made by the appropriate authority related projects of Ward Budget, where sanction has been made by the appropriate authority
5. The order shall supersede all previous orders and shall come into force with immediate effect and shall remain valid until further orders
