**ORDER**

Sub.: Delegation of powers to Sri Suwendu Kumar Sahu, OAS (SAG), Additional Commissioner-II (I/C), BMC under Section 121 of OMC Act, 2003 in relation to Public Works except Engineering & Sanitation Cell carried out by Bhubaneswar Municipal Corporation, Bhubaneswar.

2. Whereas, Additional Commissioners are being appointed by Government of Odisha as posts mentioned in Schedule-A under Rule-17 of Odisha Municipal Corporation Rule, 2004.
6. Whereas, Section-121 of Odisha Municipal Corporation Act, 2003, clearly defines powers and functions of Deputy Commissioners which inter alia includes Joint Commissioners & Additional Commissioners appointed by Government.
7. Therefore, I, Sri Vijay Amruta Kulange, IAS, Commissioner, Bhubaneswar Municipal Corporation in exercise of the powers conferred on me under Section-121(1) of Odisha Municipal Corporation Act, 2003 & Govt. in H & UD Department Gazette Notification No. SRO 211/2017 dated 10.05.2017 delegate the Financial Powers and functions relating to all branches except Engineering & Sanitation Cell given in Schedule-A of this order to Sri Suwendu Kumar Sahu, OAS (SAG), Additional Commissioner-II (I/C), Bhubaneswar Municipal Corporation, Bhubaneswar.
8. In view of the above, as per Section-121(2) all such acts done by Additional Commissioner is deemed to have been performed and done by the Commissioner and the Additional Commissioner will exercise these powers subject to the same liabilities, restrictions and the conditions to which the Commissioner is subjected under the Odisha Municipal Corporation Act, 2003.
9. The order shall supersede all previous orders and shall come into force with immediate effect and shall remain valid until further orders.
