Sub.:- Delegation of powers to Sri Suvendu Kumar Sahu, OAS (SAG), Additional Commissioner-II, BMC under Section 121 of OMC Act, 2003 in relation to Establishment Section of Bhubaneswar Municipal Corporation, Bhubaneswar.

- Whereas, Additional Commissioners are being appointed by Government of Odisha as posts mentioned in Schedule-A under Rule-17 of Odisha Municipal Corporation Rule, 2004.
- 2. Whereas, Section-121 of Odisha Municipal Corporation Act, 2003, clearly defines powers and functions of Deputy Commissioners which inter alia includes Joint Commissioners & Additional Commissioners appointed by Government.
- 3. Therefore, I, Sri Vijay Amruta Kulange, IAS, Commissioner, Bhubaneswar Municipal Corporation in exercise of the powers conferred to me under Section-121(1) of Odisha Municipal Corporation Act, 2003 & Govt. in H & UD Department Gazette Notification No. SRO 211/2017 dated 10.05.2017 delegated the powers and functions relating to functioning of Establishment Section as given in Schedule of this order to Sri Suvendu Kumar Sahu, OAS (SAG), Additional Commissioner-II, Bhubaneswar Municipal Corporation, Bhubaneswar.
- 4. In view of the above, as per Section-121(2) all such acts done by Additional Commissioner is deemed to have been performed and done by the Commissioner and the Additional Commissioner will exercise these powers subject to the same liabilities, restrictions and the conditions to which the Commissioner is subjected under the provisions of Odisha Municipal Corporation Act, 2003.

5. The order shall supersede all previous orders and shall come into force with immediate effect and shall remain valid until further orders.

Schedule-A

<u>Delegation under Section-121 of OMC Act-2003 for Establishment matters of Bhubaneswar municipal Corporation.</u>

- Mattres such as sanction of leave, Increment, House Rent Allowance, Sanction of Pension, Gratuity, Retirement notice, Festival Advance, GPF/CPF Files of Group-B officers and Gropu-C & D staff of Corporation shall be done by Additional Commissioner in charge of Establishment.
- 2. Any matter which cannot be decided as per the said rules and procedures of Government must be put up to Commissioner, BMC
- 3. All matter such as Increment, House Rent Allowance, Sanction of Pension, Gratuity, Retirement notice, Festival Advance, GPF/CPF Files, sanction of deputation, sanction of CL & EL pertaining to Group-A officers shall be done by Commissioner / Mayor, BMC as the case may be.
- 4. All the matters related to disciplinary proceedings, transfer & posting of all Gropu-A & B officers of Gevernment / Corporation and Group-C staff of Corporation shall be placed before the Commissioner, BMC.
- 5. Matters related to transfer and posting of Group-C & D, DLR and CLR staff of Corporation shall be done by Additional Commissioner in-charge of Establishment. However, the matters related to disciplinary proceedings of Gropu-D staff shall be placed before the Commissioner / Mayor, BMC as thecase may be.
