PUBLIC NOTICE

The Authority proposed to dispose of un-allotted cut piece lands available adjacent to the allotted house/ residential/ commercial plots within the Housing/Plotted Development/ Commercial Scheme of Bhubaneswar Development Authority (BDA) in the manner specified under Chapter-IV of BDA Land(Disposal and Allotment) Regulation 2015 amended time to time and on such other terms & conditions fixed by BDA & as per the decision of 102 Authority meeting held on 11.01.2008 vide item No.19/102.

The allottee, adjoining/adjacent to the available cut piece plots/lands may offer for allotment in the form prescribed by BDA on/or before 3rd March'2021. The BDA shall examine each application on case by case basis on such criterion/criteria including the followings:-

- (i) The left out patches of land within the buildable area of the scheme which cannot be used otherwise or developed as independent residential or commercial plots may be considered for allotment to the land owner who has a plot contiguous or adjacent to it.
- (ii) The additional land can be allotted on payment of price which is equivalent to double of the present Benchmark value.
- (iii) The applicant should not have encroached any public road, drain and/or land of State Governments, Statutory body and/or of the BDA.
- (iv) The original allotment must not be through discretionary quota and/or of double allotment and/or contrary to allotment procedure and/or subject matter of any litigation.
- (v) Original allotted land or property must have been utilized for the purpose for which it was allotted.
- (vi) Adequate justification must exist for allotment of such additional land.
- (vii) This scheme is not applicable in case of flat/apartment/shops.
- (viii) BDA reserves its right to impose such other Condition(s), Criterion(s), Principle(s) and Procedure(s) at its discretion(s) over and above the conditions aforesaid which shall be final and binding to the selected applicants.
- (ix) BDA also reserves its rights to cancel the process at any stage and/or to reject any application without assign any reasons thereof and/or in case any misrepresentation of facts and forged documents are found at any stage. The decision of the Authority concerning the allotment shall be final and binding to the parties.
- (x) The application form alongwith requisite verification may be downloaded from BDA website <u>www.bda.gov.in.The</u> applicants need to filled up the application form alongwith verification and submit the same alongwith the requisite documents as mentioned in the procedure available in the website.

- 4. Indemnity Bond as per prescribed format (attached herewith).
- 5. Copy of Identity Proof (Aadhar/PAN/Voter I.D/Passport) of the applicant.
- 6. Schematic plan of the land parcel applied adjacent to the allotted land clearly showing the land applied and its measurement.
- 7. Copy of updated Holding tax & Ground rent payment receipt.
- 8.The allottees whose allotment covered under the Discretionary Quota, Multiple allotment & name has been included in the Task Fore Report & Audit Report are not elligible to apply.
