ADDENDUM - I

BMC invited the RFP for auction of Advertisement rights on Govt. Land in North and South-West Zone vide RFP No. 22687 dated 26.04.2022. In this connection, a Pre-bid meeting was held under the Chairmanship of Additional Commissioner II, BMC on 05.05.2022. In pursuance to the decisions taken in Pre-bid meeting, following conditions are added under Minimum Eligibility Criteria in addition to existing criteria.

S. No	Following Conditions added in Minimum Eligibility Criteria	Documents required to be submitted in technical proposal by Applicant
1	The applicant must have valid trade license for the current financial year i.e., 2022-23 and trade license must be issued by Bhubaneswar Municipal Corporation. Provisional trade license will not be considered for evaluation. For avoidance of doubt, this clause may be read as clause 2.4.1. (E) of Section-2	Applicant shall have to submit a Photocopy of valid trade license for the current financial year i.e., 2022-23
2	The applicant should not have any arrears dues payable to BMC. For avoidance of doubt, this clause may be read as clause 2.4.1. (F) of Section-2	Affidavit certifying that the Applicant doesn't have any arrears dues payable to BMC

Other terms and conditions as laid down in RFP shall remain in force. However, all intended applicants are required to meet the aforementioned criteria along with the other criteria as mentioned in RFP under the clause 2.4 of Section-2 (Minimum Eligibility Criteria).
