1. During the period of the contractual appointment, the appointee shall also be entitled to get Travelling allowance / Daily allowance in the requisite grade and scale/level as admissible to their regular counterparts on performance of official tour with the approval of competent authority.
2. Such re-engagement shall be governed by the procedures and rules laid down vide Government of Odisha, G.A Department Resolution No.23750/Gen. dated.27.08.2014. The monthly consolidated remuneration of re-engaged will be fixed as per Para-2 of Finance Department Office Memorandum No.24533/F dated.29.09 .2022.
3. The period of contractual engagement shall not be counted as Government Service for the purpose of pension and any other retirement benefits.
4. The engaged officer will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

The contractual engagement may be terminated at any time by the Bhubaneswar Smart City Limited (BSCL) for unsatisfactory performance, on notice of one month and in case of any misconduct including, but not limited to, misappropriation, negligence or causing loss to Government, without any prior notice.
