ODISHA DEVELOPMENT AUTHORITIES (PLANNING AND BUILDING STANDARDS)(AMENDMENT) RULES, 2021

S.R.O.No.456/2021 — Whereas the draft of the Odisha Development Authorities (Planning and Building Standards)-(Amendment) Rules,2021 was published as required under section 125 of Odisha Development Authorities Act.,1982 (Odisha Act. 14 of 1982) in the Extraordinary issue No.306 of the *Odisha Gazette* dated the 22nd February,2021 under the Notification of the Government of Odisha in the Housing & Urban Development Department No. 4187-HUD-TP-POLICY-0003-2020, dated the 22nd February, 2021 inviting objection and suggestions from all persons and Authorities likely to be affected thereby, till the expiry of a period of 15 days from the date of publication of the said Notification in the *Odisha Gazette*.

And, whereas, objections and suggestions received in respect of the said draft before the expiry of the period so specified have been duly considered by the State Government;

Now, therefore, in exercise of the powers conferred by Section 123 of the said Act., the State Government do hereby make the following rules, namely:—

- 1. Short title, extent and commencement.—(1) These rules may be called the Odisha Development Authorities (Planning and Building Standards) (Amendment) Rules, 2021.
- (2) They shall extend to all the "development areas" which are so declared under sub-section (1) of Section 3 of the Odisha Development Authorities Act., 1982.

- (3) They shall come into force on the date of their publication in the Odisha Gazette.
- 2. In the Odisha Development Authorities (Planning and Building Standards) Rules, 2020 (hereinafter referred to as the Said Rules), in sub-rule (1) of Rule 37 for Table No. 9 the following table shall be substituted, namely:—

- **3.** In the said Rules, in Rule 43, after clause (viii), the following clause shall be inserted, namely:—
 - "(ix) Toilet blocks not connected to sewer system shall have onsite sanitation systems like septic tanks constructed as per IS: 2470 (Part-1)-1985 and Leach Pit constructed as per IS: 12314-1987"
