GIS BASED COMPREHENSIVE DEVELOPMENT PLAN FOR EXTENDED AREA OF BHUBANESWAR, 2040

NOTIFICATION

The 13th October 2025

No. 19713—Planning (MP) 54/22-BDA—Whereas, the Draft GIS-based Comprehensive Development Plan (CDP) for the extended area of Bhubaneswar, 2040 was earlier published under Section 12 of the Odisha Development Authorities Act, 1982, in the Odisha Gazette (Extraordinary Issue No. 458) dated the 2nd March, 2024, inviting objections and suggestions from the public within the stipulated period as specified therein;

And whereas, the objections and suggestions so received in respect of the said draft were duly examined and considered by the Board of Enquiry constituted under Rule 14 of the Odisha Development Authorities Rules, 1983;

And whereas, due to certain issues pertaining to revenue matters in respect of 35 (thirty five) revenue villages out of the total 364 revenue villages notified in the aforesaid draft, it has been considered necessary to re-publish the Draft GIS-based Comprehensive Development Plan for the said 35 revenue villages under the extended area of Bhubaneswar, 2040, as specified in Table–I below;

Now, therefore, notice is hereby given that the said Draft GIS-based Comprehensive Development Plan for the aforesaid 35 revenue villages has been prepared and is available for inspection in the office of the Bhubaneswar Development Authority, Akash Shova Building, Sachivalaya Marg, Bhubaneswar, during office hours on all working days except Saturdays, for a period of 90 (ninety) days from the date of publication of this notice in the Odisha Gazette.

Objections or suggestions to the aforesaid plan with any request for personal hearing if any, may be sent in writing to the Secretary, Bhubaneswar Development Authority.
