No. 13318-BDA-TP-PLAN-0001/2026-BDA.—Bhubaneswar Development Authority, in exercise of power conferred on it under Sub-Section-1 of Section 23 of Odisha Development Authorities Act, 1982; declare its intention to prepare Town Planning Scheme No.-07/2026 for Mouza (Part)- Malipada and Daspur under Development area of Bhubaneswar Development Authority, Bhubaneswar. Details of the areas proposed to be covered under this Town Planning Scheme are as follows:

1. **Town Planning Scheme No. 07/2026** for Mouza (Part) Malipada and Daspur area will be prepared for approximately 154.339 hectares (381.38acres).
2. Name of the Revenue Mouza (Part) covered:
 - a) Malipada
 - b) Daspur
3. **Town planning Scheme No. 07/2026** for Mouza (Part)-Malipada and Daspur will be prepared for approximately **154.339 hectares** (381.38 acres) of land. The Town planning Scheme No. 07/2026 for mouzas (part) Malipada and Daspur is bounded by (part/full plot numbers as the case may be)

- a) **North:** Starting from West to East side TPS-07 boundary is being bounded by adjoining plots 159(P), 197, 189, 186(P), 196, 491, 562 of Daspur Mouza and boundary of Town Planning Scheme No. 08/2024.
- b) **South:** Starting from East to West side TPS-07 boundary is being bounded by adjoining plot 136, 307, 94(P) of Malipada Mouza and proposed Town Planning Scheme No. 06/2026.
- c) **East:** Starting from North to South side TPS-07 boundary is being bounded by adjoining plots 314/1184, 314, 315, 319, 321, 322, 323, 324, 329 of Shyampur Mouza.
- d) **West:** Starting from South to North side TPS-07 boundary is being bounded by adjoining plots 41, 40, 35, 34, 33, 31, 30, 27, 24, 23, 22, 21, 20, 19, 18, 17 of Gothapatana Mouza.
