INVITATIONS FOR BIDS (I. F. B.) BID IDENTIFICATION No. BDA/362-EE-II/2019-20

Executive Engineer, Division No.II, B.D.A, Bhubaneswar on behalf of Bhubaneswar development Authority invites **Percentage Rate bids in single cover system** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the following work through 'e' – Tendering only.



Requirements under Goods & Service Tax Act.


The supplier of goods or service or both shall submit the tax invoice for release of payment and the tax invoice should include all the particulars and contents as required under section-31 of the CGST/SGST/IGST/UTST Act, 2017 read with rules made there under, including the followings:

- a. Correct Name, Address & GST No. of both the Supplier and recipient.
 - b. "Tax Invoice" should be clearly mentioned on the invoice copy.
 - c. GST should be clearly mentioned separately.
 - d. Correct classification of supply of goods, services or both should be made.
 - e. Nature of supply whether it is interstate or intra state should be mentioned.
 - f. Place of supply should be mentioned.
 - g. Prevailing rate of tax should be clearly mentioned.
 - h. Levy of Tax whether as forward charge or reverse charge should be mentioned.
 - i. The supplier shall submit a original copy of Tax Invoice to the Authority (BDA).
- A. The supplier shall declare that the tax so collected from the Authority will be duly discharged either by using input tax credit or paid as per provisions under GST Act.
 - B. The supplier shall declare that the supply date as mentioned in the invoice will be disclosed correctly in the relevant monthly return (such as GSTR-1, GSTR-2, GSTR-3, GSTR-3B and other relevant forms).
 - C. The supplier shall also agree that he will compensate for input tax credit if not allowed to Authority due to non-disclosure or improper disclosure in the aforesaid returns as required under GST Act.
 - D. If the supplier is unregistered under GST Act., in that case the supplier should submit an undertaking that his turnover is within the threshold limit.
 - E. Anti-profiteering clause. : The supplier should declare that the benefit on account of change of rate of GST and input tax credit will be passed on to the Authority by way of reducing the contract prices and there shall not be any double taxation.
 - F. As and when GST Law requires deduction of withholding tax i.e., TDS under section 51 of GST Law, BDA shall deduct such tax as per prevailed provisions.
 - G. Supplier of goods shall issue way bill as and when required as per provisions of GST law for supply of goods.
1. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms & Conditions of contract and other necessary Documents can be seen in the website <http://tendersodisha.gov.in>.
 2. Bids must be accompanied by uploaded scanned copies of bid security and cost of bid documents including GST of the amount as specified for the work in the table along with bid documents during online submission. The cost of bid documents including GST shall be in shape of demand draft issued from any Nationalized Scheduled Bank located in the State in favour of Executive Engineer, Division No.II, BDA, Bhubaneswar. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Tender submitted without E.M.D / Bid Security or part E.M.D / part Bid Security / unpledged E.M.D / unpledged Bid Security / E.M.D partly / Bid Security partly pledge and partly unpledged / E.M.D / Bid Security in other forms shall not be considered and such tenders shall be out rightly rejected.
 3. The Bid documents will be available in the website <http://tendersodisha.gov.in> from **05/08/2019 to 5.00 P.M. of 16/08/2019.**
 4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
 5. Bids shall be received only "On-line" on or before **5.00 P.M of 16/08/2019.**
 6. Bids received "on-line" shall be opened at **11.30 A.M** on **20/08/2019** in the office of the Executive Engineer, Division No.II, BDA, Bhubaneswar, Orissa in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
 7. Balance Bid security @ **1%** of contract value shall be furnished duly pledged in favour of Executive Engineer-II, BDA, Bhubaneswar **other than as mentioned in Col.6** at the time of execution of agreement.

8. Original Bid Security & Demand draft towards cost of bid document must reach in the office of Executive Engineer, Division No.II, BDA, Bhubaneswar by Speed Post / Registered Post only after bid closing date i.e. from **17/08/2019** and before **5.00 P.M. of Dt.19/08/2019** during office hours on working days failing which the bid will be rejected.
 9. The cost of bid documents has to be paid by each bidder in shape of demand draft drawn in favour of **Executive Engineer-II, BDA, Bhubaneswar as mentioned at Col.7** from any Nationalized Scheduled Bank payable at **Bhubaneswar**.
 10. **Qualification Requirement as per relevant clauses of DTCN attached here with should be fulfilled.**
 11. Other details can be seen in the bidding documents.
 12. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in on-line bidding".
 13. If any of the intending bidders wish to withdraw from participation in the bid, he / she can freely **withdraw** from the participation before scheduled date and time of closure of the bid.
 14. **Additional Performance Security** shall be deposited by the successful bidder before execution of agreement when bid amount is less than the estimated cost put to tender. In such an event, the bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the amount not less than the differential cost (i.e. estimated cost put to tender minus the accepted tender value) as Additional Performance Security in shape of Demand Draft / Term Deposit Receipt pledged in favour of the Executive Engineer, Division-II, BDA, Bhubaneswar and payable at Bhubaneswar before execution of agreement failing which bid will be cancelled with forfeiture of EMD. The successful bidder has to deposit the Additional Performance Security in the prescribed format within 07 (Seven) days from the date of issue of LOA failing which his tender will be cancelled & EMD will be forfeited.
 15. The authority reserves right to cancel the bid without assigning any reason thereof.
- Minimum Eligibility Criteria:-**
The intending bidders should have valid Registration Certificate of class of Contractor / EPF & ESI Code Number / GST Clearance Certificate & PAN Card to participate in the tender. The tender must be accompanied with E.M.D / Bid Security as mentioned in **Column No.6** in shape of **NSC / POTD / FDR / TDR from any Nationalized Bank** duly pledged in favour of the Executive Engineer, Division No.II, BDA, Bhubaneswar.


