INSTRUCTIONS TO BIDDERS

Definitions:

“Agency” means a legally-established Reputed Security Agency or an entity that may provide or provides the Services to the Client under the Contract.

“Authority” means Bhubaneswar Smart City Ltd., Odisha that signs the Contract for the Services with the selected Agency.

“Contract” means a legally binding written agreement signed between the Client and the Agency and includes all the attached documents listed.

“Government” means the government of the Client’s State.

“Guidelines” means the policies of the Government of Odisha set forth in this RFP.

“RFP” means the Request for Proposal prepared by the Client for the selection of Agency.

“Services” means the work to be performed by the Agency pursuant to the Contract.

“TORs” means the Terms of Reference that explain the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Agency, and expected results and deliverables of the assignment.

Inviting quotations for hiring of Security Agency for providing Security Personnel to Bhubaneswar Smart City Ltd.

A. Background and Objectives:

Bhubaneswar Smart City Limited (the “Authority”) invites Bids from reputed and experienced Security Agencies (the “Bidder”) to provide Security Personnel to Bhubaneswar Smart City Limited (BSCL) at Bhubaneswar, Odisha.

B. Broad Scope of Work:

- The Authority initially intend to hire 06 (six) nos. of Security Personnel who shall be placed in Bhubaneswar Smart City Ltd. Office.
- 06 (six) nos. of Security Personnel will be placed on a daily basis over a period of 3 (three) shifts each shift having 8 (eight) hours.
- In each shift total 2 (two) nos of Security Personnel will be deployed.
- The requirement of BSCL may increase or decrease during the contract duration.
- The Agency will provide proper uniforms, shoes, hat and other equipment’s as required for smooth functioning of Security services at their own cost.
- Prevention of theft and pilferage of the BSCL property at different location.
- Protect BSCL’s property from sabotage and damage.
- Prevent unauthorized entries.
- During watch and ward duties, proper dress code/Uniform is mandatory. No casual dressing is allowed.
- Any other duties as may be assigned by BSCL from time to time.
- Authority reserves the right to terminate the Agreement during the contract period with providing a 30 (Thirty) days’ notice to the Agency without citing a reason thereof.

C. Contract Period:

The Agreement will be initially for a period of 1 (one) year and can be further extended based on the Mutual consent of both the Parties based on the same terms and conditions or with some additions/ deletions/ modifications for further specific period mutually agreed upon by the Authority and the Agency subject to a maximum of 1 (One) annual term.

D. Technical and Financial Eligibility Criteria

1. The Registered Office of the Bidder should be located at Bhubaneswar, Odisha.
Proof required-An attested copy of the registration certificate of offices at Bhubaneswar, Odisha, shall be enclosed.
2. A Bidder should be a single entity, any type of consortium is not allowed.
3. A Bidder can be a company incorporated under the Indian Companies Act (ii) a trust registered under the Indian Trusts Act, 1882 or the Bombay Public Trusts Act, 1950 (or other applicable laws) or (iii) a society registered under the Societies Registration Act, 1860 (or other applicable laws) or (iv) a not-for- profit company incorporated under Section 8 of the Indian Companies Act, or (v) a

Partnership firm registered under The Partnership act, 1932 or the Limited Liability Partnership (LLP) incorporated under Limited Liability Partnership Act 2008 Government of India (vi) a Proprietorship firm.

4. The Bidder should have undertaken minimum 3 (Three) security contracts of engagement of 20 or more security personnel for a duration of 2 (Two) year to State or Central Government Departments/Ministries/Government Undertakings, Public Sector Companies/Banks/Central and in last **3 (three)** financial years. **(Proof of work orders/ copy of Agreement along with payment of receipt to be attached)**
5. The Bidder should have a minimum annual turnover of INR 40 (Forty) lakhs from the business of providing Security services, each year during last three financial years i.e., 2017-18, 2018-19, 2019-20.
6. The Bidder should have a minimum of 100 (hundred) no. of active Security Personnel appointed as on the Bid due date under its registered firm/ entity/ company etc. **(It is mandatory to submit a self-declaration certificate stating number of Security Personnel employed under the firm/ entity/ company as per the format given in Appendix-II)**
7. One Bidder can submit only one Bid, in case of additional bid submitted by the same Bidder, the Bid shall be summarily rejected and the entire EMD to be forfeited.
8. A Bidder must not have, during the last 3 (three) years, failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitrator or judicial authority or a judicial pronouncement or arbitration award against the Agency, nor been expelled from any project or agreement nor have had any agreement terminated for breach of contract by such Agency.

E. Selection of Successful Bidder:

1. The Bidder who quotes the lowest per day price as per the format given in Envelope- 'C', Appendix-III will be selected as a "Successful bidder". The quotation should be exclusive of Applicable GST.
2. The quoted rates shall not be less than the latest minimum wages notified by Govt. of Odisha under the Minimum Wages Act,1948 and the Odisha Minimum Wages Rules,1956 and shall include all statutory obligations. The rates quoted should be consolidated and inclusive of Income Tax, Employer EPF contribution, ESI Contribution, bonus, insurance, leave salary etc. The offer of the Security Agency which does not abide by the minimum wages Act, as notified by central government on the date of submitting of Bid will be out rightly rejected.
3. In the event of revision of minimum wages fixed by Government of Odisha are more than rates quoted by the Bidder, the rates shall be revised accordingly. The Onus for producing the copy of notification will be of Security Agency.

F. Cost of Bid Document

INR. 2,000 (Two thousand) in the form of DD in favor of "Chief Executive Officer, Bhubaneswar Smart City Limited, payable at Bhubaneswar, Odisha.

G. Earnest Money Deposit (EMD)

The bidder should deposit Earnest Money Deposit (EMD) of INR 40,000/- (Rupees Forty thousand only) refundable in the form of Demand Draft / Pay order payable to “Chief Executive Officer, Bhubaneswar Smart City Limited, payable at Bhubaneswar, Odisha. All bidders have to deposit the EMD along with the Bid document. The bid without EMD shall be summarily rejected and no correspondence will be entertained on this subject.

EMD shall be forfeited in the following cases:

- i. If any information or document furnished by the Bidder turns out to be misleading or untrue in any material respect; and
- ii. If the successful Bid fails to execute the Agreement within the stipulated time or extension thereof, if any granted by BSCL.

The EMD of the Unsuccessful bidders to be returned within 60 (sixty) days from Bid due date. The EMD for the successful bidder to be returned based on the submission of Performance Bank Guarantee as per the Point H given below.

H. Performance Bank Guarantee

The Successful bidder will have to deposit Performance Bank Guarantee of 10% of the Agreement value from a reputed Bank. The performance bank guarantee should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations by the firm. In case the Agreement is further extended beyond the initial period, the performance bank guarantee will have to be accordingly renewed by the Successful Bidder.

I. Validity of Bid

Bid shall remain valid for 120 (One Hundred Twenty) days from the BID Due date.

- vii. Self-attested copy of the PAN card and GST certificate shall be attached with the Bid document
- viii. Power of Attorney as per Appendix-I
- ix. Documents in support of eligibility criteria
- x. Whole Bid Document Duly signed and sealed by Authorized signatory of the Bidder.

- I. The BID shall be typed or written in indelible ink and each page shall be initialed by the authorized signatory having Power of Attorney. All the alterations, omissions, additions, or any other amendments made to the BID shall also be initialed by the person(s) signing the BID.

K. Opening of Bid

The Chief Executive Officer or any officer authorized by him, shall open the Bids. The officers competent to dispose of the Bids shall have right of rejecting all or any of the Bids.

L. Rights of the Chief Executive Officer

The Bids that are found responsive in Terms of the Bid document shall only be considered. The Chief Executive Officer or any officer of BSCL authorized by Chief Executive Officer reserves the right to call for clarification or additional document as deemed fit. A Bid shall be considered responsive only if:

- i. Technical Proposal is received as specified in this Bid document;
- ii. It is received by the Bid Due Date including any extension thereof;
- iii. it is signed, sealed, hard bound and marked as stipulated in Clause J;
- iv. it is accompanied by the EMD as specified in Clause G;
- v. it is accompanied by the Power(s) of Attorney as specified in Clause I, as the case may be;
- vi. it contains all the information (complete in all respects) as requested in this Bid Document (in formats same as those specified);
- vii. it does not contain any condition or qualification; and
- viii. it is not non-responsive in terms hereof.

N. Terms and Conditions of the Agreement

1. The Agreement will be initially for a period of one year, commencing from the date of signing of the agreement, which may be extended for a further period of 1 (one) year on the same terms and conditions depending upon the requirement of the Authority. The Authority, however, reserves the right to terminate / curtail the Agreement at any time after giving one month's notice without assigning any reason.
2. The Agency will be responsible for deployment of Security personnel having a qualification of M.E./ Literate in local language.
3. Security Agency will ensure that all instructions of the BSCL administration are strictly followed and there is no lapse of any kind.
4. No items are allowed to be taken out of the BSCL office without proper Gate Passes issued by the competent officers as laid down in the contract for in-out movement.
5. The Security Personnel shall assist the visitors in reaching their desired department/locations,

6. The Security Personnel on duty shall not leave the premises until his reliever reports for duty.
7. Any other duties/responsibilities assigned by the BSCL may be incorporated in the agreement. The same shall also be binding on the Agency.
8. The security agency shall strictly follow the applicable labour laws with respect to maximum hours for which a security Personnel can work.
9. The Security Agency shall be responsible for engaging adequately trained manpower required for providing good Security Service.
10. The 3 (three) shifts for deployment of the Security Personnel are as follows: 6AM to 2PM, 2 PM to 10 PM, 10 Pm to 6 AM.
11. The employees of the Security Agency should possess sound health and be free from any diseases, especially contagious and frequently recurring diseases and they should be in uniform while on duty. Medical certificate in respect of fitness of Personnel/employees deputed may be produced.
12. In case of absence of the Security Personnel the Agency shall make its own prior arrangement to appoint substitute Security Personnel during the absence of the original Security Personnel.
13. The Age limit for the Security personnel to be in between 18-55 Age group.
14. The Security Agency will, prior to the commencement of the operation of contract, make available to BSCL the particulars of all the Security Personnel who will be employed such particulars inter-alia should include age, date of birth, permanent address and the police verification report of the employees should be enclosed.
15. The Security Agency shall be responsible for the payment of wages and allowances as per Minimum Wages Act in force and all statutory dues to the persons employed by him for providing the Security Services. Wages book may be maintained by the Agency in respect of each Security Personnel.
16. The Security Agency shall be responsible to maintain the equipment's and other articles supplied by the BSCL in good condition. In case of any damage Security Agency shall be responsible to carry out the repairs without any delay to avoid any interruption in service. Cost of repairs shall be borne by the Security Agency itself.
17. The Security Agency will demonstrate the firefighting equipment once in a year and would be responsible for the operation of fire fighting in the event of fire break out.
18. The Security Agency shall indemnify BSCL from any financial loss or any injury to any Security Personnel deployed by the Agency in the course of their performing functions/ duties.
19. The Security Agency shall be solely and exclusively responsible to adhere to meet out all statutory obligations under Indian law in respect of compliance of all the rules, regulations and directions given by any statutory authority with regard to safety, labour laws (ESI, PF, Bonus, Income Tax, Goods and Service Tax (GST) or any other extra taxes levied by the Govt. from time to time.) Companies Act, Tax Deduction liabilities, welfare measures of its employees and all other obligations that enjoin in such cases and are not essentially enumerated and defined herewith or any other prevalent laws and submit an undertaking and proof of payment to its employees as per minimum wages rates to BSCL each month along with claim for payment. In no circumstances BSCL will be help responsible regarding Non-payment of dues and non-deposit of statutory fees.
20. The Security Agency shall not appoint any third party to carry out any obligation under the contract.
21. The maintenance charges/ service charges/ administrative charges quoted by the agency should be reasonable but not zero or NIL.

22. The provisions of the relevant below given acts or rules to be applicable:

- The Contract Labour (R&A) Act, 1970.
- Odisha Contract Labour (R&A) Act, 1975
- Odisha Private Security Agencies Rules, 2009

O. Terms of Payment

1. No payment shall be made in advance nor any loan from any bank or financial institution recommended on the basis of the order of award of work. The Security Agency shall submit monthly invoice to BSCL within the 1st (First) week of every month strictly. The payment shall be released on monthly basis after satisfactory completion of the services. Income Tax (TDS) as applicable at prevailing rate will be deducted at source.
2. The Agency will be paid the wages for the Manpower provided+ applicable employer PF + ESI contribution + Management fee/ Services charges/ admin fee as discovered through Bidding.
3. The monthly invoice should be accompanied by:
 - Certified copy of Attendance register.
 - Certified copy of the salary/ wage register indicating the wages paid to those Security Personnel deployed in BSCL.
 - Certified copy of Employee State Insurance and payment of provident fund challan for the previous month regarding payment made showing the name of the concerned Security Personnel.
 - Certified copy of documents showing the payment of the professional tax of the previous month or any other tax as applicable.
4. The Authority shall be at liberty to withhold any of the payments in full or in part subject to recovery of penalties mentioned in this Bid document.
5. The term 'payment' mentioned in this para includes all types of payment due to the Successful Bidder arising on account of this Bid document excluding Earnest Money and Security deposit governed by the separate clauses of the Bid document.
6. Payments, subject to Tax Deduction at Source (TDS) shall be processed within 21 (Twenty-one) days of the submission of the complete documents.
7. Additional GST as applicable to be paid along with each bill.

P. Penalty

1. 1% of the daily amount (on prorata basis) will be deducted in case of delayed reporting by the Security Personnel and INR 500/- per day will be deducted in case of non-availability of 2(two) Security Personnel during any of the shift.
2. In case of absence of the Security Personnel the Agency shall make its own prior arrangement to appoint substitute Security Personnel during the absence of the original Security Personnel.
3. If above continues on regular basis, the Authority reserves the right to terminate the Agreement by giving one month's notice and performance security of the Successful Bidder will be forfeited.

Q. Acknowledgement by Bidder:

It shall be deemed that by submitting the bid, the firm has:

1. made a complete and careful examination of the project concept, general condition of contract, submission formalities and evaluation mechanism;

R. Resolution of Disputes

1. All legal disputes are subject to the jurisdiction of Bhubaneswar court only. Any dispute arising between the Parties shall be determined by a court of competent jurisdiction in Bhubaneswar and may upon agreement between the Parties be submitted for arbitration. The Arbitration shall be governed by the provisions of the (Indian) Arbitration and Conciliation Act, 1996.

S. Language

The Bid and all communications in relation to or concerning the Selection Process shall be in English language and strictly on the formats provided in this RFP document.

T. Amendment of Request for Proposal

At any time prior to the Bid Due Date, the Authority may, for any reason, whether at its own initiative or in response to clarifications requested by the Agency, modify the Request for Proposal by the issuance of Addenda. Any Addendum thus issued will be uploaded on the Authority's website.

U. Clarifications
