If successful, the bidder who has not registered under State Government has to register under the State Government of Odisha in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the work through e-tendering only.

Bids received "on-line" shall be opened at 11.30 A.M on 22.09.2022 in the office of the Executive Engineer, Division No.III, BDA, Bhubaneswar, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of Receiving / Opening of Bids as specified, the bids will be Received / Opened on the next working day at the same time and venue.
- 7. **Bid Security declaration and Original Affidavit** (in support of authenticity of tender documents, the name of the work and Bid Identification number of tender document)

shall be reached to this office latest by 4.00 P.M. of 20.08.2022 during office hours on working days by Registered Post/ Speed Post only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents; also a scan copy of the same must be uploaded during online bidding.

Cost of Bid Document in shape of Demand Draft must be received by the 8. undersigned through Registered Post / Speed Post (Not through Courier Service) addressed to the Executive Engineer-III, Akash Sova Building, Sachivalaya Marg, Bhubaneswar-751001 and Super Scribed "NAME OF WORK clearly on top of the envelop Up to 4.00 P.M. Dt. 20.08.2022 during working days, which will be opened at 5.00 P.M. on 20.08.2022 failing which the bid will be rejected.

If the office happens to be closed on the stipulated date of closing / opening of bids . 9. as specified, the bids will be closed / opened on the next working day at the same

time and venue.

The cost of bid documents has to be paid by each bidder in shape of demand draft 10. drawn in favour of Executive Engineer, Division No. III BDA, Bhubaneswar from any Nationalized bank (mentioned in column 7 of above table) payable at, Bhubaneswar separately towards cost of tender paper and GST respectively.
