4. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class Class III.
5. Bids shall be received “On-line” only through Govt website <https://tendersodisha.gov.in> on or before **5.00 P.M** on **22.8.2022**. Bids submitted online through website other than <https://tendersodisha.gov.in> will not be accepted.
6. Bids received “on-line” shall be opened at **11.30 A.M** on **25.8.2022** in the office of the Executive Engineer, Division-IV, BDA, Bhubaneswar, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office

Original copies of Bid Security declaration shall be submitted to this office latest by **10.30 A.M. on 25.8.2022** during office hours on working days by **registered post/ speed post** only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents; also a scan copy of the same must be uploaded during online bidding.

Cost of Bid Document in shape of Demand Draft and from any Nationalized /Scheduled Bank and shall be pledged in favour of the Executive Engineer, Division No-IV, BDA, Bhubaneswar payable at Bhubaneswar and shall be submitted to this office latest by **10.30 A.M. on 25.8.2022** during office hours on working days by **registered post/ speed post** only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents, also a scan copy of the same must be uploaded during online bidding.
9. Original affidavit (in support of authenticity of tender document, the name of the work & bid identification no. of tender document), must be submitted in the office of the Executive Engineer, Division-IV, BDA, Akash Shova Building, Sachivalaya Marg, Bhubaneswar-751001, Odisha latest by **10.30 A.M. on 25.8.2022** during office hours on working days by **registered post/ speed post** only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents.
10. The ST/SC contractors willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document and the original affidavit along with original RC book will be submitted latest by **10.30 A.M. on 25.8.2022**. Otherwise they will not be entitled to avail such facilities.

12. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in on-line bidding".
13. If any of the intending bidders wish to withdraw from participation in the bid, he / she can freely withdraw from the participation before scheduled date and time of submission of the bid.

15. The authority reserves the right to cancel any or all bids without assigning any reason thereof.
16. **Additional Performance Security** shall be deposited by the successful bidder before execution of agreement when the bid amount is less than the estimated cost put to tender. The Additional Performance Security in shape of **Bank Guarantee from any Nationalized/ Schedule Bank of India counter guaranteed by its local branch in Bhubaneswar / Term Deposit Receipt pledged in favour of the Executive Engineer, Division-IV, BDA, Bhubaneswar and payable at Bhubaneswar**, before execution of agreement failing which bid will be cancelled with forfeiture of EMD. The Additional Performance Security will be over and above the performance security. The additional performance security in any

Modified O.M. No.4559 Dt.05.04.2021 :

Amended vide O.M. No.4559 Dt.05.04.2021 of Works Department, Govt. of Odisha to fix the following rate of Additional Performance Security (APS).

Sl. No.	Range of difference between the estimated cost put Tender & Bid Amount	Additional performance security to deposited by the successful bidder.
1.	Below 5%	No. Additional Performance Security

  - Switch gear:- 36 (Thirty six) months
  - Post top pole:- 36 (Thirty six) months
- The bidder has to submit along with his bid documents in original as well as upload during online tendering, the Authorization certificate from at least 03(Three) Nos from SI No-(a) and 02 (Two) Nos. of Manufacturers from SI No- (b) to (d) of the following items which the bidder intends to supply (from the makes specified in the "Technical Specification") as well as upload in online or else the bid is liable for rejection.
