1. **The Engineer Member, B.D.A.** on behalf of Bhubaneswar development Authority, Bhubaneswar invites **Percentage Rate** bids in **Double Cover System** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of **Building Works** and **Park works**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility within a week before signing of the agreement.

6. Bids shall be received "On-line" only through Govt. website <https://www.tendersodisha.gov.in> on or before 5.00 P.M of 14.12.2022. Bids submitted online through website other than <https://www.tendersodisha.gov.in> will not be accepted.

Bids received "on-line" shall be opened at **11.30 A.M** on **17.12.2022** in the office of the **Engineer Member, BDA, Bhubaneswar**, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. **Bid Security declaration** shall be submitted to this office **latest by 5.00 P.M. of 16.12.2022** during office hours on working days by **Registered post/ Speed Post only**, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents, also a scan copy of the same must be uploaded during online bidding. If the last date of submission of the offline documents declared as /falls on holiday, the documents will be received till the next working day upto 5.00 PM at the same venue.

Cost of **Bid Document** in shape of **Demand Draft** and from any Nationalized /Scheduled Bank and shall be pledged in favour of **Executive Engineer, Division No-III, BDA, Bhubaneswar** and shall be submitted to this office **latest by 5.00 P.M of 16.12.2022** during office hours on working days by registered post/ speed post only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents, also a scan copy of the same must be uploaded during online bidding. If the last date of submission of the offline documents declared as /falls on holiday, the documents will be received till the next working day upto 5.00 PM at the same venue.
10. **Original affidavit** (in support of authenticity of tender document, the name of the work & bid identification no. of tender document) must be submitted in the office of the Engineer Member BDA, Akash Shova Building, Sachivalaya Marg, Bhubaneswar-751001, Odisha **latest by 5.00 P.M of 16.12.2022** during office hours on working days by registered post/ speed post only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents. If the last date of submission of the offline documents declared as /falls on holiday the documents will be received till the next working day upto 5.00 PM at the same venue.

The **ST/SC contractors** willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document and the original affidavit along with original RC book will be submitted **latest by 5.00 P.M of 16.12.2022** Otherwise they will not be entitled to avail such facilities.

14. Checklist is to be duly filled in.




