The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility within a week before signing of the agreement.





5. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**
6. Bids shall be received "On-line" only through Govt. website <https://www.tendersodisha.gov.in> on or before 5.00 P.M of 08/12 /2022. Bids submitted online through website other than <https://www.tendersodisha.gov.in> will not be accepted.
7. Bids received "on-line" shall be opened at **11.30 A.M** on **14/12/2022** in the office of the **Executive Engineer, Division NO I, B.D.A.,** Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
8. **Bid Security (EMD) (As per Annexure-)** shall be in form of **Bid Declaration Form (AS per Annexure)** *shall be submitted to this office latest by 5.00 P.M of 13 / 12 /2022* during office hours on working days by registered post/ speed post only, failing which the bid will be rejected. BDA will not be responsible for postal delay in receiving the documents, *also a scan copy of the same must be uploaded during online bidding.*

The **ST/SC contractors** willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document and the original affidavit along with original RC book with will be submitted **latest by 5.00 P.M of 13/12/2022**. Otherwise they will not be entitled to avail such facilities.


