If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility within a week before signing of the agreement.

Bids (Cover-I) received "on-line" shall be opened at **11.30 A.M** on dt.**09.06.2023** in the office of the **Engineer Member, BDA, Bhubaneswar**, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue. The Bid(Cover-II) will be opened after evaluation and will be intimated separately through "e" Procurement.

Original **Bid Security (EMD)** shall be in form of **TDR/NSC/BG** from any Nationalized /Scheduled Bank and shall be pledged in favour of **Chief Horticulturist, BDA** and shall be submitted to this office **latest by 5.00 P.M of 08.06.2023** during office hours on working days by **Registered post/ Speed post/Courier only**, failing which the bid will be rejected.
