3. Bids shall be received only "On line" on or before 21.9.2023 up to 17.00 Hours. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III.

4. Bids received on line shall be opened at 11.30 Hours on 27.9.2023 in the office of Executive Engineer, Division-IV, BDA, Bhubaneswar in the presence of the bidders who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

Validity of Tender: Validity of tender shall be for a period of 90 days from the date of opening of the tender (Financial bid).

6. Bids must be accompanied by scanned copies of Registration Certificate, EMD and required affidavit in the prescribed form appended in DTCN indicating name of the work and Bid Identification No., valid HT registered under Government of Odisha, PAN, valid EPF & ESI registration No., GST Certificate and cost of bid documents during online bidding. Bid submitted without the above documents in the prescribed format will be rejected.

7. EMD in shape of NSC / POSBA / POTD / KVP / TDR / Bank Guarantee from any Nationalized/ Scheduled Bank of India counter guaranteed by its local branch in Bhubaneswar duly pledged in favour of the Executive Engineer, Division-IV, BDA, Bhubaneswar (specified in Column No.4 of IFB) shall be submitted to this office latest by

If the last date of submission of the offline documents declared as /falls on holiday, the documents will be received till the next working day up to 10.30 AM at the same venue. Bid submitted without the above documents in the prescribed format will be rejected.

8. Cost of Bid Document in shape of Demand Draft from any Nationalized /Scheduled Bank and shall be pledged in favour of the Executive Engineer, Division No-IV, BDA, Bhubaneswar payable at Bhubaneswar and shall be submitted to this office latest by 10.30 A.M. on 27.9.2023 during office hours on working days by registered post or speed post only, failing which the bid will be rejected. Also a scan copy of the same must be uploaded during online bidding failing which the bid will be rejected. The cost of bid documents in any other form will not be accepted. BDA will not be held responsible for

postal delay in receiving the documents.

9. The bidders must submit the cost of Bid documents in original. EMD in original and affidavit in original duly notarized by a Notary registered in Govt of Odisha in an Indian non judicial stamp paper worth Rs 10.00 (required affidavit in the prescribed form appended in DTCN in support of authenticity of tender document, the name of the work & bid identification no. of tender document), original documents required under minimum eligibility criteria in the office of the Executive Engineer Division-IV. BDA Bhubaneswar in a sealed envelopes super scribing name of the work and Bid Identification No on top of the envelope to be received on or before 10.30 AM on 27.9.2023 by speed post or registered post on working days failing which the bid will be rejected. Only envelopes containing these documents shall be considered for opening prior to opening of the Technical bid for evaluation. The Authority is not held responsible for any postal delay in receipt of these documents within stipulated date and time.

verification, otherwise they will not be entitled to avail such facilities.

13. Additional Performance Security shall be deposited by the successful bidder before execution of agreement when the bid amount is less than the estimated cost put to tender. The Additional Performance Security in shape of Bank Guarantee from any Nationalized/Scheduled Bank of India counter guaranteed by its local branch in Bhubaneswar / Term Deposit Receipt pledged in favour of the Executive Engineer, Division-IV, BDA, Bhubaneswar and payable at Bhubaneswar before execution of agreement failing which bid will be cancelled.
