Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

The Additional Performance Security in shape of Bank Guarantee from any Nationalized/ Scheduled Bank of India counter guaranteed by its local branch in Bhubaneswar / Term Deposit Receipt pledged in favour of the Executive Engineer, Division-IV, BDA, Bhubaneswar and payable at Bhubaneswar before execution of agreement failing which bid will be cancelled. The Additional Performance Security will be over and above the performance security. The additional performance security in any other form will not be accepted. If the Contractor fails to complete the work, the amount so furnished as additional performance security will be forfeited in addition to the other penalty, if any to be imposed.
