Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue. The Bid (Cover-II) will be opened after evaluation and will be intimated separately through "e" Procurement.
