Executive Engineer, Division No.III, B.D.A, on behalf of Bhubaneswar Development Authority invites **Percentage Rate** bids in **Single Cover system** as mentioned for the construction of work as detailed in the table given below, from eligible Firms / Agencies / Contractors / Companies as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under State Government has to register under the State Government of Odisha in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the work through e-tendering only.

2. Bids must be accompanied by Earnest Money Deposit / Bid security of the amount specified for the work in the table above in shape of POTD / POSB / F.D. / TDR / NSC / KVP duly pledged in favour of **Executive Engineer, Division No.III BDA, Bhubaneswar**. Bidders desirous to hire machineries or equipments from outside the State or owned but deployed outside the state are required to furnish 2% of the amount put to tender as Bid security. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. Tender submitted without EMD or part EMD / unpledged EMD / EMD partly pledged and partly unpledged / EMD in other forms shall not be considered and such tenders shall be out rightly rejected.
3. The Bid documents will be available in the website <http://tendersodisha.gov.in/> from **26.09.2023 to 5.00 P.M. of 05.10.2023**.
4. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class III.
5. Bids shall be received only “On-line” on or before **5.00 P.M of 05.10.2023**.
6. Bids received “on-line” shall be opened at **11.30 A.M on 10.10.2023** in the office of the **Executive Engineer, Division No.III, BDA, Bhubaneswar, Odisha** in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of

- Receiving / Opening of Bids as specified, the bids will be Received / Opened on the next working day at the same time and venue.
7. Balance Bid security @ 1% of contract value shall be furnished duly pledged in favour of the Executive Engineer, Division No.III, BDA, Bhubaneswar at the time of execution of agreement
 8. Original Bid Security and Demand Draft towards cost of bid document must be received by the undersigned through **Registered Post / Speed Post** (Not through Courier Service) addressed to the *Executive Engineer-III, Akash Sova Building, Sachivalaya Marg, Bhubaneswar-751001* and **Super Scribed "NAME OF WORK ... clearly on top of the envelop Up to 4.00 P.M. Dt. 09.10.2023 during working days, which will be opened at 5.00 P.M. on 09.10.2023 failing which the bid will be rejected.**
 9. *If the office happens to be closed on the stipulated date of closing / opening of bids as specified, the bids will be closed / opened on the next working day at the same time and venue.*
 10. The cost of bid documents has to be paid by each bidder in shape of demand draft drawn in favour of **Executive Engineer, Division No. III BDA, Bhubaneswar** from any Nationalized bank (mentioned in column 7 of above table) payable at, Bhubaneswar **separately towards cost of tender paper and GST** respectively.
 11. The criteria governing as per DTCN will be considered for qualification of covers.
 12. Other details can be seen in the bidding documents.
 13. This notice is to be read with all the Clauses / addendum to the "Procedure to participate in on-line bidding".
 14. Checklist is to be duly filled in.
 15. If any of the intending bidders wish to withdraw from participation in the bid, he / she can freely withdraw from the participation before scheduled date and time of closure of the bid.
 16. **All Corrigendum and Addendum will be published in the Website only.**
 17. All documents should have all pages numbered and that will be clearly mentioned in the checklist.
 18. As and when GST Law requires deduction of withholding tax i.e. TDS under section-51 of GSTG Law, BDA shall deduct such tax as per prevailed provisions.
 19. Supplier of goods shall issue way bill as and when required as per provisions of GST law for supply of goods.
 20. The authority reserves right to cancel the bid without assigning any reason thereof.
