





If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue. The Bid(Cover-II) will be opened after evaluation and will be intimated separately through "e" Procurement.

15. The authority reserves right to cancel the bid without assigning any reason thereof.


