INVITATIONS FOR BIDS (IFB)

1. Executive Engineer, Division-IV, BDA, Bhubaneswar on behalf of Bhubaneswar Development Authority invites percentage rate bids in *double Cover system* conforming to the Detailed Tender Call Notice (DTCN) from **Manufacturer/ Authorized system Integrator having authorization from OEM of Intercom system**, having PAN and valid EPF & ESI registration No., GST Certificate for the item of work mentioned in the table below.

N.B. - The quoted rate should be all inclusive but excluding G.S.T. applicable under works contract.

2. Bidders not registered with Government of Odisha, should be registered under Odisha Government before the award of contract failing which the bid security shall be forfeited.
3. The Bid documents will be available in the website: <https://tendersodisha.gov.in> from **19.03.2024**. Any addendum/corrigendum/cancellation of tender can only be seen in the said website.
4. Bids along with cost of tender paper and EMD (Bid Security) shall be received only **"On line"** on or before **28.03.2024** up to **17.00 Hours**. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-III.
5. Bids received **on line** shall be opened at **11.30 AM on 30.03.2024** in the office of Executive Engineer, Division-IV, BDA, Bhubaneswar in the presence of the bidders who wish to attend. Bidders can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
6. Validity of Tender: Validity of tender shall be for a period of **90 days** from the date of opening of the tender (Financial bid).
7. Bids must be accompanied by scanned copies of required affidavit in the prescribed form appended in DTCN indicating name of the work and Bid Identification No., Manufacturer/ Authorized system Integrator having authorization from OEM of Intercom system, PAN, valid EPF & ESI registration No., GST Certificate and copies of system generated payment receipt of cost of bid documents and EMD (Bid Security) during online bidding. Bid submitted without the above documents in the prescribed format will be rejected.
8. Other details can be seen in the bidding documents.
9. The authority reserves the right to cancel any or all bids at any moment without assigning any reason thereof.
10. The ST/SC contractors willing to avail the facilities as fixed by Government shall have to upload scanned copy of the affidavit for the same along with tender document and produce Contractor

the original affidavit along with original RC book before the competent Authority for verification, otherwise they will not be entitled to avail such facilities.

11. **Additional Performance Security** shall be deposited through online by the successful bidder before execution of agreement when the bid amount is less than the estimated cost put to tender **failing which bid will be cancelled**. The Additional Performance Security will be over and above the performance security. The additional performance security in any other form will not be accepted. If the Contractor fails to complete the work, the amount so furnished as additional performance security will be forfeited in addition to the other penalty, if any to be imposed.

Modified O.M. No.4559 Dt.05.04.2021 :

Amended vide O.M. No.4559 Dt.05.04.2021 of Works Department, Govt. of Odisha to fix the following rate of Additional Performance Security (APS).

Sl. No.	Range of difference between the estimated cost put Tender & Bid Amount	Additional performance security to be deposited by the successful bidder.
1.	Below 5%	No. Additional Performance Security
2.	From 5% and above & Below 10%	50% of (Difference between estimated cost put tender & Bid Amount)
3.	From 10% and above	150% of (Difference between estimated cost put tender & Bid Amount)

12. Minimum Eligibility criteria:

- i. The bidder has to upload willingness to give comprehensive guarantee on all the works executed for a period of 24months from the date of completion of the work during online bidding **or else the bid is liable for cancellation**.
