Engineer Member, B.D.A. on behalf of Bhubaneswar development Authority, Bhubaneswar invites **Percentage Rate** bid in **Double Cover System** through **ONLINE MODE** only for the electrical work as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of **Electrical work**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility within a week before signing of the agreement.

Bids (Cover-I) received "on-line" shall be opened at **11.30 A.M** on dt. **23.10.2024** in the office of the **Engineer Member, BDA, Bhubaneswar**, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue. The Bid (Cover-II) will be opened after evaluation of Cover-I and will be intimated separately through "e" Procurement.
8. The **ST/SC/Engineering contractors** willing to avail the facilities as fixed by Government will submit scan copy of the affidavit for the same along with tender document.


