**General Manager (Engg.), CRUT, Bhubaneswar** on behalf of Managing Director, CRUT invites **Percentage Rate** bids in **DOUBLE COVER SYSTEM** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of Civil Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the following work through 'e'-Tendering only.



The cost of bid documents including GST shall be in shape of demand draft issued from any Nationalized Scheduled Bank located in the State in favour of **Capital Region Urban Transport, Bhubaneswar**. Tender submitted without Bid Security or in other forms shall not be considered and such tenders shall be out rightly rejected.
3. The Bid documents will be available in the website <http://tendersodisha.gov.in> from **22/11/2024 to 5.30 P.M. of 09/12/2024**.
4. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III**.



5. Bids shall be received only “On-line” on or before **5.30 P.M of 09/12/2024**.
6. Bids (Cover -1) received “on-line” shall be opened at **11.30 A.M on 16/12/2024** in the office of the G.M (Engineering), CRUT, Bhubaneswar, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
7. Proposals must be accompanied by Bid Security, pledged in favour of the **Capital Region Urban Transport** and will have to be in the form as specified in the DTCN.
8. **Original Bid Security (EMD)** shall be in form of **TDR/NSC/BG** from any Nationalized /Scheduled Bank and shall be pledged in favour of **Capital Region Urban Transport, Bhubaneswar by Speed Post / Registered Post** only and shall be submitted to this office **latest by 5.30 P.M of 13/12/2024** during office hours on working days, failing which the bid will be rejected. CRUT will not be responsible for postal delay in receiving the documents, also a scan copy of the same must be uploaded during online bidding.
9. The **COST OF BID DOCUMENTS** has to be paid by each bidder in shape of **DEMAND DRAFT** from any Nationalized / Scheduled Bank payable at **Bhubaneswar** drawn in favour of **Capital Region Urban Transport, Bhubaneswar**.
10. Qualification Requirement as per relevant clauses of DTCN attached here with should be fulfilled.

12. Checklist is to be duly filled in. All documents should have all pages numbered and that will be clearly mentioned in the checklist.
13. This notice is to be read with all the Clauses / addendum to the “Procedure to participate in on-line bidding”.
14. If any bidder intends to withdraw from participating in the bid, they can do so any time before scheduled date and time of closure of the bid.
15. **The successful bidder before execution of agreement shall deposit Additional Performance Security** if bid amount is less than the estimated cost put to tender. In such an event, the bidder who has quoted less bid price / rates than the estimated cost put to tender shall have to furnish the amount not less than the differential cost (i.e. estimated cost put to tender minus the accepted tender value) as Additional Performance Security in shape of **Term Deposit Receipt/ Bank Guarantee** pledged in favour of the **Capital Region Urban Transport, Bhubaneswar and payable at Bhubaneswar** within 07 (Seven) days from the date of issue of LOA before execution of agreement failing which bid will be cancelled.
