1. GENERAL TERMS & CONDITIONS

1.1 The Authority proposes to undertake a pilot project for enhancing the aesthetics, preservation, and public engagement with statues located within its jurisdiction. The project will involve the design and installation of customized shades of varying sizes, integrated with lighting systems and hybrid power solutions, along with provisions for historical information dissemination and long-term maintenance. The Authority looks forward to receiving innovative and comprehensive proposals from experienced agencies.

1.2 Eligibility Criteria:

Interested agency must meet the following criteria Registered office at Bhubaneswar

- a) The agency shall have a minimum experience in similar works (design and installation of shades, lighting systems, hybrid power solutions, or equivalent urban infrastructure projects). The agency shall submit the Company profile with details of relevant experience.
- b) The agency shall have a proven track record of executing projects for government bodies, public sector undertakings, or reputed institutions.
- c) The agency shall have adequate technical manpower, equipment, and financial capacity to undertake the project.
- d) The agency shall have to submit evidence of past work in similar domains (completion certificates, photographs, references).
- e) The agency shall have to submit proposed methodology for installation, QR code integration, and five-year maintenance.
- f) The agency shall have to submit Manufacturer Authorization Certificate (if applicable) and certifications (if any).

1.3 Scope of Work

The selected agency shall be responsible for:

- Designing and installing shades of different sizes suitable for statues.
- Provision of design lights (spot and strip) on shades and supporting pillars.
- Hybrid power system (12 Hour Back-up): integration of solar and electricity-based supply for uninterrupted illumination.
- Maintenance of the installed system for a period of five (5) years under the pilot project framework.

1.4 Deliverables

- The agency shall have to submit at least more than one design option for the shades including drawing with proposed material and cost estimate;
- Detailed Bill of Materials (BoM) with specifications of lighting fixtures, solar panels, electrical components, structural elements and others.
- Implementation plan covering installation schedule, safety measures, and maintenance protocols.

1.5 Specifications and Standards

All relevant guidelines /IS codes and IS Standards are to be followed.

Specification of Materials: -

(i) Fibre, Steel, etc. shall be procured from primary producers/OEM and should meet the BIS Standard and/or minimum standards used in India. All other materials and finishes, including furniture and other ancillary components, must be in conformance with the IS standards & specifications and as per the approval of the Client representative.

2. CONSTRUCTION/DEVELOPMENT AND MAINTENANCE OF THE COMPONENTS:

2.1 The broad scope of work is indicated as below. The detailed scope of work shall be ascertained from the design & drawings.
