1. **Executive Engineer, Division No.II, B.D.A.** on behalf of Bhubaneswar development Authority, Bhubaneswar invites **PERCENTAGE RATE** bids in **DOUBLE COVER SYSTEM** for the construction of works as detailed in the table, from the class of eligible contractors as mentioned in column-5 (five) registered with the State Governments and Contractors of equivalent Grades / Class Registered with Central Government / MES / Railways for execution of **Civil works**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the State Government of Odisha in appropriate class of eligibility within a week before signing of the agreement.

- Bids (Cover-I) received "on-line" shall be opened at **11.30 A.M on dt.08.09.2026** in the office of the **Executive Engineer, Division No.II, BDA, Bhubaneswar**, Odisha in the presence of bidders or their authorized agents who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as

- specified, the bids will be opened on the next working day at the same time and venue. The Bid(Cover-II) will be opened after evaluation and will be intimated separately through "e" Procurement

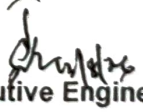

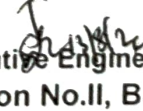
